- Eliminating discrimination, harassment and victimisation and any other conduct prohibited under the Act.

#### 1.1 What is the overall aim of your proposed strategy/policy/project etc and what are its key objectives?

The overall aim is to review resources within Communities Services unit area, to enable efficiency savings that link to the wider restructure that has been implemented in 2021/22 year with a view to the budget setting and budget build process for the ongoing Services, Directorate and Council requirements for the 2022/23 budget build and development.

The budget savings proposal reflects the consolidation of the resources previously identified in the head of communities and the head of Leisure services areas into a revised new Sport and Leisure Manager Service Manager role reporting to the Head of Neighbourhoods. The residual sport and leisure service delivery and contract monitoring will be undertaken by this new post.

The revised structure to the ongoing resources will enable the leisure concession contracts to be managed, the support work for leisure policy and strategy development and relevant links to key governing bodies and external funding opportunities, the ongoing work to support community grants and the Borough's leisure and community related Trusts in line with the new wider Neighbourhoods service structure.

The impact on the protected characteristics will be minimal and it is not considered that there will be any discrimination compared to the non-protected characteristics.
