#### **Guidance notes**

##### **What is an EqIA and why do we need to do it?**

The Equality Act 2010 places a 'General Duty' on all public bodies to have 'due regard' to:

- Eliminating discrimination, harassment and victimisation and any other conduct prohibited under the Act.
- Advancing equality of opportunity between those with 'protected characteristics' and those without them.
- Fostering good relations between those with 'protected characteristics' and those without them.

EqIAs are a systematic way of taking equal opportunities into consideration when making a decision, and should be conducted when there is a new or reviewed strategy, policy, plan, project, service or procedure in order to determine whether there will likely be a detrimental and/or disproportionate impact on particular groups, including those within the workforce and customer/public groups. All completed EqIA Screenings are required to be publicly available on the council's website once they have been signed off by the relevant Head of Service or Strategic/Policy/Operational Group or Project Sponsor.

##### **What are the "protected characteristics" under the law?**

The following are protected characteristics under the Equality Act 2010: age; disability (including physical, learning and mental health conditions); gender reassignment; marriage and civil partnership; pregnancy and maternity; race; religion or belief; sex; sexual orientation.

##### **What's the process for conducting an EqIA?**

The process for conducting an EqIA is set out at the end of this document. In brief, a Screening Assessment should be conducted for every new or reviewed strategy, policy, plan, project, service or procedure and the outcome of the Screening Assessment will indicate whether a Full Assessment should be undertaken.

##### **Openness and transparency**

RBWM has a 'Specific Duty' to publish information about people affected by our policies and practices. Your completed assessment should be sent to the Strategy & Performance Team for publication to the RBWM website once it has been signed off by the relevant manager, and/or Strategic, Policy, or Operational Group. The overall aim of the project is create the design and project plan work that will ultimately provide an enhanced, safer and more attractive environment for all users of Ascot High Street. The proposals will improve accessibility for visitors to the High Street by providing wider and more accessible footpaths along its length and more opportunities to safely cross the road. The proposals will include other features to provide greening to improve the aesthetic appeal of the public realm, provide shading for visitors to spend more leisure time on the High Street and to improve air quality. The road network and parking facilities will be laid out to accommodate through traffic, cyclists and pedestrians and make parking available to visitors choosing to drive to the High Street. By improving accessibility to the High Street, the aim is to encourage users to shift from their current mode of transport to, or continue and increase their use of, sustainable transport methods to make their journey to the High Street. The sought-after improvements would benefit all users, including vulnerable users (pedestrians, cyclists and motorcyclists) as well as persons with protected characteristics (PC). The improvements would also benefit drivers of all vehicles whose journey cannot be made using sustainable transport, and their journeys, as traffic levels and subsequent traffic congestion would decrease.
